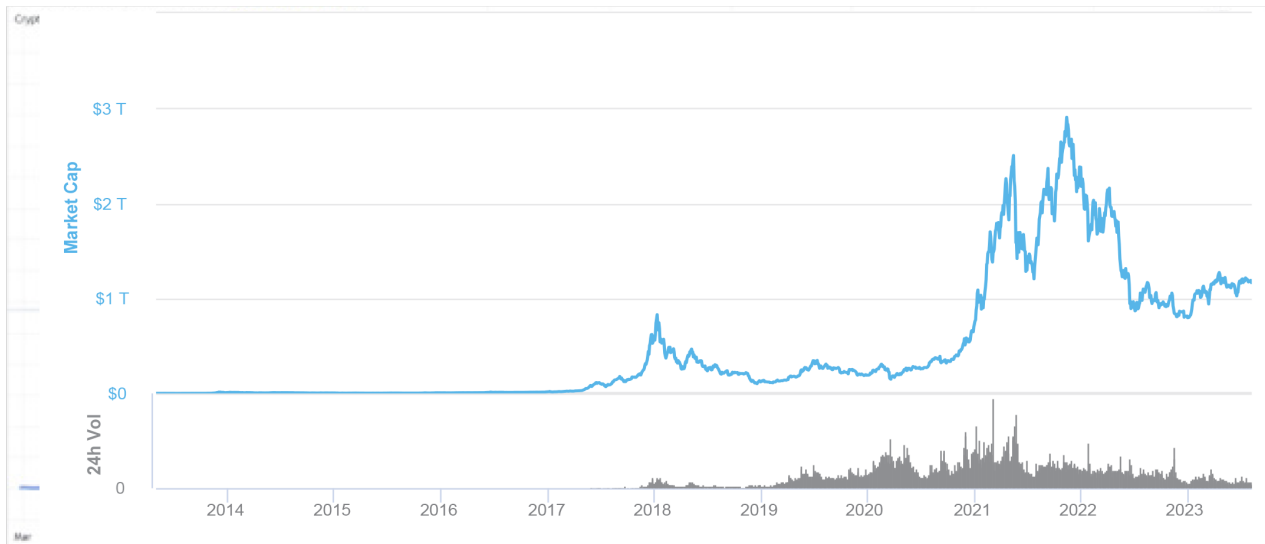

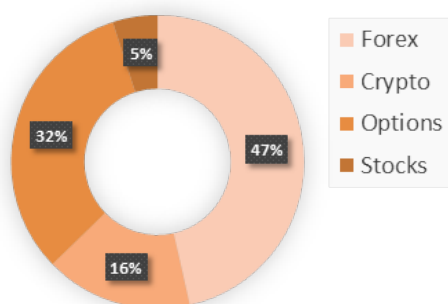

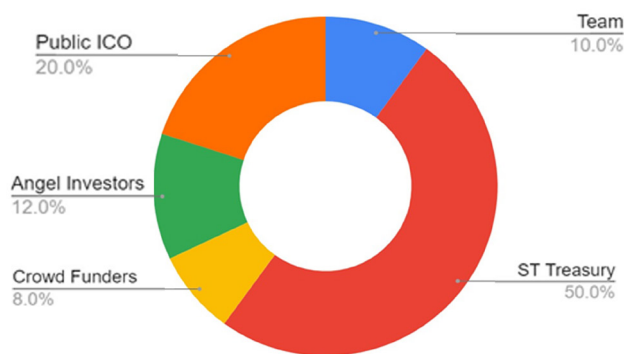
9.0 TOKENOMICS

As a result, the word tokenomics encompasses a wide range of activities and concepts, some of which are hard-coded into the protocol of a blockchain, while others are more speculative in nature.

9.2 Token Sales

Safest Trades will be utilizing its own ICO page to conduct angel investing seeding and a public ICO.

To generate more demand and create a sense of scarcity, there will be three seeding phases for the Angel Investing stage. Each phase will be active for one month or until the allocated tokens are sold out. If any tokens remain after the 30-day mark, they will be rolled over to the next phase and ultimately to the treasury.

9.2.1 Team

The 10% of tokens allocated to the team will be shared among members based on their performance and contribution to the project. This will incentivize the team to work hard and deliver on their promises. The tokens will be distributed over a period of time, with the majority being released after the project has launched and achieved certain milestones.

9.2.2 Crowd Funders

The 8% of tokens allocated to crowd funders will be converted to new project tokens, rewarding their current investment in the platform. The tokens will be distributed immediately within the Safest Trade platform.

In accordance with SFT token launch, crowdfunding investors are required to migrate their investments into the SFT token. For the smooth conversion process, crowd funders will be offered a rate of 0.10 USDT, allowing them to seamlessly

transform their initial investment into SFT tokens. Once the migration is completed, the USDT-denominated packages will be reflected as SFT denominated packages, and all future returns will be provided exclusively in SFT coins.

To ensure prudent token management, any remaining SFT tokens following the migration will be securely transferred to the ST Treasury, where they will be reserved for future requirements. In the event of a shortfall, tokens from the treasury will be utilized to meet any outstanding needs.

The initial P-P trading and a swap pool will be accessible via the Safest Exchange website, offering a user-friendly and efficient means of converting investments. Additionally, to further enhance convenience for our valued investors and crowd funders, we plan to list the SFT-USDT pair on a prominent decentralized exchange (DEX) at a later stage.

We are committed to a seamless and

transparent migration process and will provide comprehensive guidance and support throughout the conversion. As always, we value the trust and support of our investors and endeavor to create a robust and rewarding investment environment with the launch of the SFT token

9.2.3 Treasury

50% of tokens are allocated to the Safest Trade treasury. Out of the tokens allocated to the Safest Trade treasury, only 2% will be released monthly from the locked smart contract for usage, thereby effectively limiting the token supply. This allocation is dedicated to providing investment returns within the project and can also serve as a means to raise funds for future projects and initiatives, ensuring the project's long-term sustainability. The tokens will be securely held in a multi-sig wallet, and the allocation within the treasury will be governed by a DAO governance mechanism, further enhancing transparency and community involvement in decision-making processes.

9.2.4 Angel Investors

A total of 12% of the token supply will be allocated to angel investors, recognizing their vital role in contributing to the project's success. Upon receiving investments, the tokens will be locked within a smart contract, with a gradual release according to a predetermined vesting schedule. The initial 5% will be released after 90 days from the date of investment. The angel investment seed rounds will be divided into three distinct phases, providing opportunities for strategic and progressive participation. The first round will be launched at an initial price of 0.01 USDT per SFT token, offering early investors an attractive entry point. To encourage proactive engagement, the token price will increase by 25% every Monday until all available tokens are sold or the designated expiry time is reached,

fostering a fair and efficient distribution process. This approach ensures a balanced and rewarding investment experience for our valued angel investors.

9.2.5 Public ICO

The 20% of tokens allocated to the public ICO will be sold to investors in exchange for selected cryptocurrencies and stablecoins. Retail investors can use these tokens to invest in the Safest Trade platform or sell them on the open market to anyone interested in investing in the platform.

9.3.1 Treasury

50% of the token supply will be allocated to the Safest Trades Treasury. To ensure utmost security and prudent management, all funds within the treasury will be subject to a secure smart contract lock, thereby mitigating any potential risks and excess supply.

Only 2% of the locked funds will be released at the end of each month, ensuring a controlled and sustainable approach to managing the treasury resources. This monthly release of 2% allows for strategic allocation of funds, such as payments to investors, community rewards, and other essential project expenditures.

9.3.2 Team

A designated 10% of the total token supply will be thoughtfully allocated to the Safest Trades Team as a recognition of their invaluable performance and contributions to the project. This allocation will be distributed based on individual team members' merits and their impactful involvement in driving the project's success. The first allocation will be made on 31st Aug 2023. To ensure a well-balanced and sustainable approach, only 5% of this allocation will be released once every 91 days. This phased-release strategy reinforces a diligent and measured distribution of tokens, reflecting the team's continued dedication and commitment to achieving our shared objectives.

9.3.3 Crowd Funders

Designated 8% of the total token supply will be thoughtfully allocated to the early crowd funders who have shown their support and trust in the Safest Trades platform. This allocation will be specifically utilized to facilitate the seamless migration of their current investments into SFT tokens. Importantly, there will be no restrictions on this allocation, providing users with the freedom and
